



# Commissioner Dean: It's time to 'fish or cut bait' on beach restoration

# County Commission to vote Oct. 16 on bed tax increase

Next Tuesday, Oct. 16, the St. Johns County Board of County Commissioners will finally provide an answer to the "will they-won't they" question of the year by voting to either approve or reject a 1-percent increase in the county's tourist development tax to help fund beach renourishment. With time running out to

shore up support for the proposal, Commission Chair Henry Dean said it's now or never for those who wish to save the county's beaches.

"Really, it's fish or cut bait, next Tuesday," Dean said regarding the upcoming vote. "We need at least four of our five commissioners to vote for this, and I hope that we have that support."

The tourist development tax, commonly known as the "bed tax," is a tax on short-term living accommodations and is currently levied at 4 percent in St. Johns County. According to county officials, increasing the tax to 5 percent could generate an additional \$2.2 million annually for

beach renourishment, the push for which has been mounting since Hurricanes Matthew and Irma exacerbated the county's longstanding problem of coastal erosion.

Currently, St. Augustine Beach is the only portion of St. Johns County that has an ongoing beach restoration program. Help for South Ponte Vedra and Vilano beaches, however, may not be far off, as not only has the state approved funding for a one-time sand placement due to the impacts of Hurricane Matthew, but the U.S. Army Corps of Engineers will also be spending federal funds on a long-term beach renourishment program for that area.

The downside, however, is that for the one-time sand placement, the county will still be responsible for paying half the cost of the roughly \$20-million project, and for the long-term project, the county will need to contribute about \$19.1 million. Further, Ponte Vedra Beach proper will not benefit from either of those projects.

Dean, who advised that the county is looking into a low-interest loan with a 30-year payback period for the federal project, contended that there would be no point in moving forward with any projects without the bed tax increase.

# THE PLAYERS Championship makes surprise donation to CAF/CNL Golf Tournament

THE PLAYERS Championship presented a check donation of \$50,000 to the Challenged Athletes Foundation (CAF) and Camp No Limits (CNL) Golf Tournament on Monday, Oct. 1 at the Golf Club at South Hampton in St. Augustine.

The charity was initially expecting to receive \$25,000, but Jared Rice, the executive director of THE PLAYERS, surprised the organization by presenting a check for \$50,000 instead.

As part of the presentation, the CAF and CNL Golf Tournament also presented a wheelchair for basketball to Daniel Phillips, an 11-year-old boy who was born with a congenital clubfoot, absence of fibula and hip dysplasia dislocation, all in his right side. His foot was amputated when he was 13 months old, and he was fit with his first prosthetic leg when he was 2 years old. He had his last amputation at the knee when he was 4 years old. Now happy and healthy, he is a big sports fan and thanks to Brooks Adaptive Sports and Recreation, he was introduced to wheelchair basketball.

CAF provides opportunities and support to people with physical challenges so they can pursue active lifestyles through physical fitness and competitive athletics. CNL provides camps for children with limb loss, and education, mentorship and support to these children and their families. The annual golf tournament, started by Ponte Vedra residents Jim and Carolyn Houston nine years ago, benefits both organizations, as well as the HEAL Foundation, Angelwood, Juvenile Diabetes Research Foundation, the Tesori

Family Foundation, 50 Legs, the Never Say Never Foundation and Giving to Fly.

Inspired to raise money for people who give to others, the Houstons started the golf tournament after their son Tim, an above-the-knee amputee, received his first grant from CAF when he 6 or 7 years old. Since its founding, their foundation has donated over \$350,000 to other charities.

CAF/CNL volunteer Tera Lageman

introduced THE PLAYERS to the annual golf tournament after being involved for several years, and she said the donation will be a gamechanger.

"They are going to be able to take that money and help dozens of families in our area and beyond," she said. "It's pretty cool that I get to be part of something like that."

Jim Houston, who is the general man-

ager of the Golf Club at South Hampton, said THE PLAYERS donation proved to him that good things come to people who do good for others.

"When people understand the cause of what we raise money for, your heart is your guide at that point," he said. "I think it made an impact for the folks at THE PLAYERS today. And I can tell you I'll never forget it."

# Ponte Vedra Beach Branch Library prepares for temporary closure

Beginning Friday, Nov. 2 at 6 p.m., the Ponte Vedra Beach Branch Library will close its front doors and will not reopen them to the public until March 2019.

The reason for the temporary closure, according to library officials, is a project to replace the building's fire suppression system.

"It's basically the fire sprinkler pipes inside the building, as well as the fixtures and piping that goes around the porch areas outside of the library," Branch Manager Amy Ring advised. "All of those pipes are going to be replaced, so it's a pretty big project and a few years in the making."

According to Ring, the extensive project is to be completed by W.W. Gay Mechanical Contractor, Inc. and is estimated to cost about \$187,800.

"We've had issues with leaks," she explained. "They had done some work in the past to try to find less costly solutions to fix any issues with leaks and the general deterioration of the system, but those at-

tempts have not been successful, so it was determined by (county engineers) that the best thing is to just replace the system."

But while the library building will be closed for several months, Ring advised that a temporary storefront will be accessible at the St. Johns County Tax Collector's Annex for most of that period.

"The week of Nov. 5, we won't be offering library services in Ponte Vedra at all," she said, "because for that week, library staff will be readying the building and moving equipment and everything that we'll need for the next couple months to that Tax Collector's Annex at 5430 Palm Valley Road. We're going to open that to the public on Tuesday morning, Nov. 13 at 11 a.m."

From Nov. 13 through the branch's reopening, the temporary storefront will operate under abbreviated hours, from 11 a.m. to 6 p.m. Monday through Friday, and from 11 a.m. to 4 p.m. on Saturday. During those hours, patrons will be able to request and pick up holds, drop off returns and browse the library catalogue, as well as a limited selection of items.

Recognizing that the schedule change will present a challenge to some patrons, Ring said that library staff will be making a few adjustments to better accommodate everyone.

"Everything will either check out for three weeks, two weeks or one week, so that people have a chance to get to us while we're open," she said.

Additionally, Ring noted that the time limit on holds will be extended from four to seven days, to give patrons more time to pick up their items, and added that the closure will not impact the building's use as an early voting site or Election Day polling place.

"The building will still be available for early voting the whole day on Saturday, Nov. 3, and it will be open on polling day on Nov. 6," she said. "It's just that people will need to enter the library through the southeast, double green doors."

Throughout the upcoming closure, patrons will still be able to contact library staff at the Ponte Vedra Beach Branch's main phone number of (904) 827-6950. While the exact completion date for the project is uncertain, Ring said she is hopeful that the library will be reopened by March 1 and encouraged patrons to visit www.sjcpls.org/closure/ to stay informed of any updates.

# Fire damages apartment complex in Ponte Vedra Beach, temporarily displaces residents

A fire on Monday afternoon damaged three apartments in The Coast at Ponte Vedra Lakes, an apartment complex located at 611 Ponte Vedra Lakes Blvd.

According to St. Johns County Fire Rescue spokesman Jeremy Robshaw, the fire did not cause any injuries to residents. Robshaw said the Oct. 8 fire has temporarily displaced the residents living in those three units. Two of the apartments, he said, sustained much less serious damage than the third.

Both St. Johns County Fire Rescue and the Jacksonville Beach Fire Department responded to the incident. According to Robshaw, the cause of the fire is still under investigation.

"What we've tried to do as best we know how is to come up with a way to fund both our portion of the federal project and the 50-percent match to the state's one-time placement," he said. "We also need to do the first steps in doing what we can for the Ponte Vedra Beach area ... but without the 1-cent increase in the bed tax, the foundation of our house crumbles and our whole effort for restoring and renourishing these beaches, from Vilano up to Ponte Vedra Beach, basically falls."

Citing a 2018 study done by James R. Houston of the U.S. Army Engineer Research and Development Center, Dean noted that the beaches are Florida's top attraction not only for tourists, but also for potential homebuyers, and that neglecting the beaches could have dire economic consequences for St. Johns County as a whole.

"Already this year, because of the damage from Matthew and Irma, property values along the beachfront — home values and land values — have gone down about 20 percent," he said. "If we lose our beach protection, not only will there be damage to those homes east of A1A, there'll be damage to those homes west of A1A, so I think it's justifiable to say that we could be

subject to a potential loss of up to 20 percent of our ad valorem revenue if we don't take the bull by the horns and protect and renourish our beaches."

Adding that the Tourist Development Council unanimously voted to recommend the increase, Dean also pointed out that most of St. Johns' neighboring counties levy a bed tax of 5 percent or more. In Flagler and Clay counties, for instance, the tax is levied at 5 percent, and in Duval and Volusia counties the tax is as high as 6 percent.

Local support for beach renourishment has been strong among beachfront property owners, with a portion of the funding for the Vilano and South Ponte Vedra Beach projects already being collected through a municipal service taxing unit. The county also recently conducted a survey regarding a potential MSTU for Ponte Vedra Beach proper, to which 92 percent of respondents (443 property owners) answered favorably.

Stressing the urgency of the situation, Dean said that the point of no return for St. Johns County's beaches may in fact come with next Tuesday's vote.

"We have to do something," he said, "because if we reject the 1-percent increase in the bed tax, I've played my last card. I don't know what to play next — I'm out of aces — so it's critical, in my opinion, that we go forward."

Charles Jantz, a resident of Deercreek Country Club, is the founder and volunteer chairman of the RITA Foundation, an all-volunteer, nonprofit organization that raises money for local breast cancer programs. The organization's next event, the SenioRitas women's 40+ doubles tennis tournament, is Oct. 19-21 at Sawgrass Country Club in Ponte Vedra Beach.

# Can you please tell us briefly about your background?

I was raised in Cleveland and graduated from Ohio Wesleyan University in 1961. I worked as a food services broker, forming and owning Food Service Marketing, Inc. until I sold it in 1993 and retired to Jacksonville. Coming to a new city absolutely knowing no one, I met friends through playing tennis and getting every free job in the Deercreek community. I was president of the Deercreek Homeowners Association twice, a member of the Board of Governors for the Deercreek Country Club for eight years and the chairman of the Deercreek Tennis Committee for five years.

#### What's the story of the RITA Foundation?

As tennis chairman, Deercreek wanted to have an event, and I suggested a women's tournament, which they liked. Then, I picked breast cancer as the charity, as it runs in my wife's family. I made up the name RITA (Research Is The Answer), and our first event was in 1997. Over the next 10 years, I added two 5K walk/run events called Caring And Sharing Hope (CASH), a black tie gala, a Lexus golf tournament and another tennis event called SenioRITAs at Sawgrass Country Club. We additionally have the MixedRITA doubles tennis tournament benefiting prostate and breast cancer research, also held at Sawgrass.

# What has been the impact of the organization?

Our two 5Ks were open to all nonprofits as a way for them to raise money and over 40 participated. And some still do under the name, The Human Race, with the Hands on Jacksonville nonprofit. We have donated over \$1.5 million to the Breast Health Department at UF Health, primarily through the Lexus Golf event. We have also donated over \$1 million to Baptist Health, including Baptist Cancer Institute, Baptist Nassau, Baptist South and Baptist Beaches, and over \$1 million to the Mayo Clinic. To this day, we remain an all-volunteer 501(c)(3) nonprofit with no salaries or overhead costs. We continue to donate 100 percent of the net proceeds from three events with all money remaining in the Jacksonville area. Our grants have been used to purchase equipment (we purchased Mayo's first digital mammography machine) fund seminars, provide compression garments for Lymphedema patients, conduct basic cancer research (Dr. Al Copland's lab at Mayo) and clinical trials and provide free mammograms for the under-served. Additionally, we have funded breast cancer support groups such as Women's Center, One Women's Place and Pink Sisters.

## What do you enjoy most about living in the area?

Probably the people. We picked the area because we wanted to get away from the cold winters in Cleveland, but we did want a change in season and we do have that here. We like the fact that we have excellent healthcare. We have all the major things that you might want to do — the recreation, the outdoor living, the symphony, the theatre ... all the things that a big, big city would have with a small-city feel.



 $A voiding \ dependence \ on \ our \ children \ ranks \ as \ one \ of \ retirees' very \ worst \ fears. \ No \ one \ wants \ to \ be \ a \ financial$ burden on their children especially when so many young families are struggling to achieve financial security themselves. But what retirees should fear more than dependency is guardianship. Guardianship is where a courtappoints someone else to take the legal responsibility to manage your assets and make decisions for you. Unless you have planned to avoid guardianship, it can become required if you ever get to the point where you cannot manage your affairs, typically from cognitive ailments like Alzheimer's, or other disabling accidents or conditions.



professionals. She is responsible for advising on all legal matters including international, employment, litigation and immigration issues for the PGA Tour and the Tournament Players Clubs throughout the TPC Network.

Shetty recently helped the PGA Tour win the dismissal of a lawsuit filed in California by over 160 caddies seeking compensation for what they felt was misappropriation of their bodies by having to wear bibs that displayed the PGA Tour's tournament name and sponsor. The PGA Tour initially received a motion to dismiss the claims, but the caddies appealed to the Ninth Circuit Court of Appeals, which ultimately upheld the dismissal.

Shetty joined the PGA Tour in 2008, which is an opportunity she never thought was possible given her background and career path. She previously served as a partner in the labor and employment department of McGuireWoods LLP in Jacksonville. She also served as an in-house lawyer and human resources vice president for employee relations with Sabre Holdings, a company specializing in travel commerce, retailing travel products and distribution and technology solutions for the travel industry. She received her undergraduate degree from Duke University and her law degree from the University of Texas School of

Shetty played a few sports growing up, but never seriously, and she thought her long-term involvement with sports would be limited to being a fan. So, when the PGA Tour came calling 10 years ago, it was somewhat of a surprise for her to enter the sports industry, but an exciting one at that.

"It (sports) was always something that I enjoyed, but it always felt like something that was unattainable for my background," Shetty said. "When this opportunity at the (PGA) Tour came open and they hired me, it was amazing."

As a result, Shetty believes it's important for people, especially women, to have an open mind as they navigate through their career.

"I think, especially sometimes for women, we're sort of at an early age channeled to certain types of jobs or certain industries, and we sort of fall in line or think that's because the other options aren't available to me," she said. "I think I've sort of demonstrated the career path where as long as you keep your mind open and you keep trying to do your best in the job you have right now, that there are opportunities maybe out there and you need to be open to them and take advantage of them when they come your wav.

Shetty added that it's great for people to pursue long-term career goals and dreams, but that it's also important to not become single-minded and recognize that there could be other ways to achieve

an end goal, or that there might be other end goals that are just as appealing or better in the long-term.

Shetty is the daughter of Indian immigrants who came to the United States in the 1960s. As a result, she said she comes from a background that is slightly less traditional compared to others in her field, particularly in sports. And throughout her career, she said she's been told you have to fit into a certain expectation or follow the path of previous people to be successful, which is a mindset that has made her uncomfortable. So, she's made it a priority throughout her career to stay true to herself in her pursuit of success and recommends to others to do the same.

"I think to women of color, I would say you gotta listen to what everybody says, you have to be respectful of those different opinions and why they're being provided," Shetty said. "But at the end of the day, you have to be true to yourself and your identity because it's very hard to be something other than what you are and how you've always been.

"I think the world, as we know, is changing," she continued. "I think in some ways it's happening faster, and in other ways, it's happening slower. But I think that it's definitely changing, and we just to have to be a positive part of the change."

■ Give yourself time. Career changes are rarely an overnight process. Successfully switching careers takes time, so don't give yourself a quick deadline to make a change. Changing careers can be exciting and nerve-wracking. Affording such a switch the consideration it deserves and doing your homework can help make the switch as successful as you envision it being.

# How working women can create more leisure time

Few working professionals would likely say they could not use more leisure time. The American Time Use Survey found that men spend an average of 22 minutes per day doing housework, while women spend 50 minutes per day doing housework. Downsizing to smaller homes that don't require as much daily maintenance can provide women with more leisure time.

■ Get out of the kitchen. Cooking is a favorite leisure activity for many people. But for those who prefer to be out and about rather than preparing meals in the kitchen, cooking can be more of a time-consuming chore than a rewarding passion. The American Time Use Survey found that women spend 70 minutes per day on food preparation

and cleanup. Meal delivery services can cut down on the time it takes to prepare meals, opening up more leisure time for people who want to spend less time in the kitchen each day.

■ Make an effort to split chores down the middle. As evidenced by the time men and women spend on housework and cooking, the American Time Use Survey found that household chores are not always divided equitably among men and women. Adults who feel they do not have enough leisure time in their day can work with their spouses or significant others to ensure both partners are doing an equal amount of work around the house.

Leisure time that's spent well can contribute to a higher quality of life. Many people may be surprised to learn just how much leisure time they can enjoy each day by making a few simple tweaks to their daily routines.



and business owners with no full-time employees other than themselves or a spouse. For 2018, you can put in up to 25 percent of your annual income as an "employer" contribution, and you can defer up to \$18,500 (or \$24,500 if you're 50 or older). The sum of your employer contribution and your salary deferrals cannot exceed \$55,000, or \$61,000 if you're 50 or older. You can make elective contributions on a pre- or post-tax (Roth) basis. Pre-tax contributions reduce your taxable income for the current year. Roth contributions don't offer any immediate tax benefit, but any qualified withdrawals will be 100 percent tax-free.

- **SEP IRA** If you have just a few employees or are self-employed with no employees, you may want to consider a SEP IRA. You'll fund the plan with tax-deductible contributions, and you must cover all eligible employees. As an employer, you can contribute the lesser of 25 percent of your compensation (if you're also an employee of your own business) or \$55,000.
- Solo defined benefit plan Pension plans, also known as defined benefit plans, are less common than in previous years, but you can still set one up for yourself if you're self-employed or own your own business. This plan has high contribution limits, which are

determined by an actuarial calculation, and your contributions are typically taxdeductible.

• **SIMPLE IRA** — A SIMPLE IRA, as its name suggests, is easy to set up and maintain, and it can be a good plan if your business has fewer than 10 employees. However, while a SIMPLE IRA may be advantageous for your employees, it's less generous to you, as far as allowable contributions go, than an owner-only 401(k), a SEP IRA or a defined benefit plan. For 2018, your annual contributions are generally limited to \$12,500, or \$15,500 if you're 50 or older by the end of the year. You can also make a matching contribution of up to 3 percent of your compensation. As an employer, your contributions are fully deductible as a business expense up to certain limits; as an employee, your pretax contributions reduce the amount of your taxable income for the same tax year.

Before opening any of these plans, you'll want to consult with your tax advisor on the tax issues and a financial professional on the investment aspects. But don't wait too long. You will need to work hard to keep your business thriving — so choose a retirement plan that works just as hard for you.



# Alert! Are you over 70½ and do you have an IRA?

Before I embark on the following important narrative, our legal folks want me to inform you that my suggestion is not intended to be a substitute

for specific individualized tax advice. Please discuss your specific tax issues with a qualified tax adviser. Okay, now that the disclaimer is out of the way, let's roll!

As part of Republicans' objective to simplify the tax code, they nearly doubled the size of our standard deduction, which could mean that some people will not "itemize" this year. For example, the standard deduction amounts increased to \$12,000 from \$5,650 for individuals and \$24,000 from \$11,300 for married couples filing jointly. Therefore, if one's itemized deductions are not higher than the new standard deduction amounts, one will not get a deduction for their charitable donations. Ouch! As you might imagine, charities are bracing for a giving plunge.

Nevertheless, engaging in an IRS provision known as a qualified charitable distribution (QCD) is more advantageous than ever. To qualify for the QCD, however, you must be an IRA owner who is 70 ½ years or older. If you meet the requirement, you are allowed to make charitable contributions directly from your IRA, and the funds will go directly from your IRA to the charity. The real benefit is that you exclude the distributed money from your taxable income! Eliminating money from your income is the same thing as you taking a deduction! Additionally, your lower income reduces your adjusted gross

income, which could reduce taxes that you might be paying on your Social Security benefits.

Here is a simplified example of how the transaction takes place and the subsequent outcome; let's say that you normally give \$5,000 to charity and your required minimum distribution (RMD) is also \$5,000. Most folks would simply write a check to the charity and get a tax deduction if they itemized. The new way, for many tax savvy people is to instruct one's financial advisor to make a transfer from one's IRA

directly to charity. This transaction satisfies the RMD and the income from the distribution is not taxable!

REMINDER: IRA custodians are not required to identify the QCD on your year end 1099-R. So, the responsibility is on us to inform our tax preparer that we performed a QCD. If we don't let our CPA know, he or she will likely report the transaction as fully taxable, which would negate the benefit of our tax savvy tax planning. Moreover, the charity that receives the donation must provide the same contribution acknowledgment needed to claim a charitable income tax deduction. Failure to obtain the acknowledgment will quash the QCD.

# Sing Out Loud Festival hosts 279 acts, welcomes over 25,000 fans and raises \$98,000 for local charity

Four weekends, 18 venues, 82 showcases, 279 acts, over 25,000 music fans and \$98,000 raised for a local charity — the third annual Sing Out Loud Music Festival proved to be the largest, most successful year yet.

With fans coming as far as Austin, Texas and even South Africa, this year's festival welcomed over 25,000 people to St. Augustine over the course of four weekends between Sept. 1 and Sept. 23. Two hundred and seventy-nine acts — ranging from indie rock to punk rock, bluegrass to blues and spoken word to comedy took the stage at 18 different venues in a celebration of local, regional and national singers, songwriters, musicians and performance artists.

New this year was the Sing Out Loud Panel Discussion held at The Corazon Cinema and Café on Sept. 20. The panel, entitled "Perspectives on the Florida Music Scene: The Current State, Its Future and How Florida Artists Can Break Past the State Line," featured 10 Florida-based music industry leaders sharing their knowledge and advice on what makes the Florida music scene unique, how to further its growth and how to support local musicians. All 82 Sing Out Loud showcases were free and open to the public, with the exception of the Sept. 22 Betty Griffin Center Benefit Concert starring Jason Isbell and The 400 Unit with The Decemberists and Lucero at the St. Augustine Amphitheatre.





Through the sale of donation tickets to the Sept. 22 showcase, approximately \$98,000 was raised for the Betty Griffin Center with ancillary funds being raised during the Sept. 23 Against Me! concert

and additional donations that are still coming in. All proceeds raised were donated to the Betty Griffin Center to assist in its mission of working to end domestic violence and sexual abuse in St. Johns County.

"It has been quite amazing to see so many musicians and people in our community coming together to support such a wonderful organization as the Betty Griffin Center," said Ryan Murphy, festival organizer and director of St. Johns County Cultural Events Division. "Artists such as Jason Isbell understood from the beginning that the impact they would have on the festival and the fundraising aspect would be quite phenomenal. The true spirit of the Sing Out Loud Festival is to lift up local musicians, venues and organizations in a way that we don't get to most of the year ... and in that way I feel it was a real success this year.'

Betty Griffin Center CEO Joyce Mahr said her organization is extremely grateful for the support.

"This gift comes at a most opportune time as we try to meet shortfalls and fill in gaps as a result of an increase in more than double the numbers of services we are providing," Mahr said. "It will ensure that we can meet the demands of critical and life-saving support."

The Sing Out Loud Festival is presented by Community First Credit Union and produced by the St. Johns County Cultural Events Division (which owns and operates the St. Augustine Amphitheatre and Ponte Vedra Concert Hall), the St. Johns Tourist Development Council and the St. Johns Cultural Council. Since its inception in 2016, the St. Augustine music festival has welcomed an estimated 50,000 music fans and featured nearly 900 performing artists at multiple venues.

# PVHS alumna finishes runner-up at Pinehurst Challenge

Ponte Vedra High School graduate and Jacksonville University golfer Hannah Berman shot a 1-under 71 to finish with a career-best 216 and a first ever runner-up medalist performance at the Pinehurst Challenge earlier this week.

"I'm really proud of Hannah," Jacksonville University Head Coach and Nocatee resident Jennifer Borocz said. "She worked extremely hard in the offseason and it's showing.

"She knew she left a lot out on the course last year as she transitioned to JU and her goal this season was to step up and be a leader," Borocz added.

The junior from Ponte Vedra Beach, who transferred to JU last year to be closer to home and to have the chance to play Division I golf, entered the day tied for sixth after going 72-73 on Monday. She started and ended on a high note, birdieing her first and final two holes of the day. She finished the week with nine total birdies, third most, and was JU's best scorer on both Par 3s, where she shot even par, and on Par 4s, where her 1-over scoring was third best in the field. Her 54-hole score is tied for seventh best in program history.
