

Intermittent Nighttime closures expected on Hospital Creek Bridge

As part of the Hospital Creek Bridge improve-

ment project located on State Road A1A just west of the Vilano Bridge, intermittent overnight closures are planned for the Hospital Creek Bridge through Friday, April 23. - St. Augustine Gulf War National Guard Veteran Carl "Jeff" Lay for continuing his service, even with health issues, by serving with the Veterans Reserve Corps and the American Legion;
- Jacksonville Marine veteran Cliff Leonard, who, over the past 13 years, sculpted 50 bronze busts of fallen service members and presented each sculpture to the service member's grieving family;
- Delaware Vietnam Veteran Ron Elliott, who transported the remains of service members to their final resting place for more than 40 years;
- Redding, California's young Preston Sharp for placing flags and flowers on more than 200,000 veterans' graves;
- Maryland's Jeannie and Doug Ping for hosting annual picnics for volunteers of a used book store for summer reading programs; and
- Maryland Vietnam-era Veteran and 31-year Little League volunteer George Swanson as the Waldorf League "Go-to-Guy."

Nocatee reveals plans for future development

The demand for new homes in Nocatee has reached an all-time high, prompting The PARC Group, the community's master developer, to offer a preview of neighborhoods planned to open by the end of 2022.

Last year, Newsweek named Nocatee the top place to live in Florida. Even so, the community hasn't hit the pause button on adding to the many reasons for relocating there. New amenities will be opening this summer, two health campuses have been built and many new retailers have opened their doors in Town Center.

WHAT THE FUTURE HOLDS

Here's a look at some new neighborhoods that are in the works:

- Palmetto Cove: This intimate neighborhood of 61 homes will be located at the northeast corner of Crosswater Parkway and Nocatee Landing Trail. Homes will be between 2,600 and 4,200 square feet.
- **Seabrook:** This community of three neighborhoods is scheduled to open in late 2022. It will be located off an extension of Conservation Trail west of Pioneer Village.
- Palm Crest: This neighborhood has about 100 homes sites. Homes will be between 2,500 and 3,200 square feet.
 - Coral Ridge: This neighborhood

with controlled access has about 180 of the largest home sites in the final phase of Nocatee. Homes will start at about 3,200 square feet.

■ Seabrook Village: About 325 home sites are located within this neighborhood. Homes will be up to 2,800 square feet.

HAPPENING NOW

Here's an update of neighborhoods already under way:

- West End at Town Center: Model homes are now open. New townhome and villa designs are planned for the fall.
 - **■** Franklin Square at Crosswater:

Townhomes by Toll Brothers are scheduled to open this summer.

- **Settler's Landing:** Six builders are selling new homes in the newest neighborhood, located south of the Crosswater neighborhoods.
- River Landing at Twenty Mile: Pre-selling homesites will begin in the summer. Closings expected in early 2022.
- **Del Webb** Nocatee has released new estate homesites and plans to construct a new, 22,000-square-foot clubhouse.

MANY AMENITIES

In addition to all this home construction, Nocatee is building on its amenities. They are expected to be complete in the summer of 2021.

- A new, serenity pool will be added at Splash Water Park, and the park's bar and concessions area will be expanded. The children's playground will be moved closer to the family pool.
- A swimming pool will be constructed at Spray Water Park along with two new action slides: a dueling head-first mat slide and a tube slide.
- In the sports complex, four new pickleball courts and a new volleyball court are being constructed.

She lives St. Augustine with her husband Steve, an environmental specialist and adjunct professor at Flagler College.

Aubrie Simpson

As told to Holly Tishfield

Can you please briefly tell us about your background?

I was born and raised in suburban Ft. Lauderdale. In 2004, I relocated to Ponte Vedra Beach with my family. My family had vacationed in St. Augustine for several years prior to relocating. I am a graduate of Allen D. Nease High School. In 2012, I graduated from Flagler College with a bachelor's degree in elementary education. I earned a master of science in pre-K/primary education in 2014. I taught for three years in public, charter and private schools in St. Johns County. I taught preschool, kindergarten and reading intervention teacher in primarily Title 1 schools.

During my time teaching, I saw that there were gaps in services for students and their families. In my classroom, I had students who needed mentors and tutoring and many young parents who wanted parenting classes. These resources were not available for my students and their families. I wanted to do more to help local families, so I began volunteering in the community to learn more about services available for families and ways I could give support. I began volunteering and raising funds for numerous local nonprofit organizations. Through my volunteer work with numerous nonprofit organizations, I developed a passion for nonprofit work. In 2017, I became a board member of Kids Bridge Family Visitation Center, a local nonprofit supervised family visitation center that offers on-site supervised visits, parent exchange services and several programs and courses to help strengthen families. I began a career transition from education to the nonprofit sector.

Through my involvement with Kids Bridge, I learned more about our local foster care system and the gaps in services for children in foster care. There was no local nonprofit focused on filling in the gaps in services for children in foster care of all ages. I got together with some friends who also share a passion for helping children in foster care, and we started Fostering Connections St. Johns in February 2019. Fostering Connections St. Johns started as an all-volunteer nonprofit and has grown tremendously in the last two years. I am now the CEO of Fostering Connections St. Johns, and we serve children in foster care ages birth through age 23 and their families in St. Johns, Putnam, Flagler and Volusia counties.

In addition to my work with Fostering Connections St. Johns, I serve as a St. Johns County Chamber of Commerce ambassador and a board member of the Early Learning Coalition of North Florida.

What do you enjoy most about your role?

I enjoy many things about being CEO of Fostering Connections St. Johns; helping fill in the gaps in services for foster families, meeting community members who want to support children in care and sharing community awareness about foster care with the community. Through Fostering Connections St. Johns, I have been able to work with clients and donors from all around St. Johns County. What I enjoy most about my role as CEO is working with our Career Readiness Academy students. Career Readiness Academy is a job-skills training program for teens in the foster care system ages 14 to 18 in partnership with The Kookaburra Coffee in which teens learn job skills, are placed in a paid internship, and receive support through job coaching and monthly soft skills classes. It is so rewarding to see the students grow in their career skills, develop a passion for their chosen field, and build their confidence.



What are some of the challenges that your industry/company is facing?

There are many challenges the nonprofit sector is facing during COVID-19; connecting with our clients and supporters during social distancing, the cancellation of in-person fundraisers and programming, a shortage of volunteers and suspension of some grant funding applications. Nonprofits are all about building community connections. In 2020, the nonprofit sector had to pivot and adapt programming.

Fostering Connections St. Johns has found creative ways to connect with both our clients and supporters during this time. Currently, we have no-contact delivery of essential items for foster families. Our programming now has a hybrid approach to best service our clients; some in-person programming with social distancing in place, in-person hybrid programming with virtual attendance options, and all virtual programming. We have many flexible opportunities for volunteers to serve including virtual volunteering.

This year, we look forward to resuming in-person events and fundraisers with social-distancing precautions in place.

What are your primary roles/responsibilities?

My role as CEO of Fostering Connections St. Johns is to work in partnership with our board of directors to plan and execute the goals of Fostering Connections St. Johns. I manage and develop programming for foster youth and their families, advise the board on the annual budget and build relationships and partnerships with

Peanut butter food drive is underway

As we see all around us in Florida, palm trees are a popular staple for our landscaping. The very tall, thin palms you see everywhere are sabal palms (also known as cabbage palms), and are native to Florida.

However, there are many other beautiful types of palms that can flourish in our

Here are a few of our favorites at Kathy's Nursery: Sylvester Palms (Phoenix Sylvestris): These are one of our most popular sellers. They come in a variety of heights to fit most landscapes and create a beautiful ambience. They have a neat diamond-cut trunk, but are a large tree that needs to be a distance from the home.

Queen Palms: These palms are stately with bright glossy leaves that are gorgeous in the wind. Their fronds cascade over, which creates a tropical vibe. Bright orange dates hang in ornamental clusters. They are common around patios and pool areas of relaxation.

Bismarck Palms: These silvery blue-green palms are a show stopper with their huge fronds and robust trunk. Their fronds can span up to 16 feet. They are fast growers and thrive in full sun. Certainly a focal point of your

Robellini Palms (Pygmy Date Palms): This miniature palm is slow growing and allows you to have a palm




closer to your home. Popular at the end of driveways or front doors, robellinis are soft and feminine in look and

Sago Palms: These wide-trunk palms are dark green and lush. They will not grow to be too high with their large cone of seeds growing out of the middle. The seeds are poisonous to pets, so we tend to keep them out of our fur-friendly homes.

European Fan Palms: These palms are very hardy and slow growing. They are not sensitive to cold weather and grow 8-to-15 feet tall. Their fronds are fine-textured, which make them stick out in landscaping and the color can range from dark green to silver.

Majestic Palms: This palm loves humidity, which is perfect for our Floridian climate. The fronds fullness can fan out to 15 feet height. They are also slow growers that don't mind some shade, but love water and naturally wet

Course in St. Johns County locations bucks trend of bleak predictions

"Recent events have put so many on the edge, and the longer matters drag on, the louder the voice of helplessness becomes," said Rabbi Naftali Silberberg of JLI's Brooklyn, New York, headquarters. "If we can make — as stated in our title — a 'credible case' to be optimistic about times ahead, that is remarkably edifying."

As with all of JLI's programs, "This Can Happen" is designed to appeal to people at all levels of knowledge, including those without any prior experience or background in Jewish learning. All JLI courses are open to the public, and attendees need not be affiliated with a synagogue, temple, or other house of worship.



Judge John: Sand Life Law – Who let the dogs out?

There's a reason for the saving hu-Man's best friend. Each reader will likely have had a certain special canine come to mind on reading the subject of this article. For Judge John, she was Athena (nicknamed The Amazing Flying Wonder Dog), but from childhood Gypsy, Flick, Happy, and Rosie also come especially to mind. Apparently, humans and dogs have lived together since the very beginning of our evolution into bi-peds.

Dogs are a big part of the Sand Life.

Some breeds particularly enjoy playing in the ocean, while most enjoy running and digging in the sand. Because of health and safety concerns for both people and dogs, all of our beach cities have adopted special dog laws, including a new one very recently in Jacksonville Beach.

It is important that all dog owners be aware that the laws and rules are different depending on which beach city you are in. Some, but not all, of those differences are reviewed here. Each city has its rules on its website. In all locations at the beach, it is absolutely the owners' obligation to "pick up and properly dispose of the poop." It is the minority of dog owners who do not pick up their dogs' fecal matter who are primarily responsible for more restrictive dog laws, along with those who do not control vicious or ill-behaved dogs. Each city has the ability to fine non-complying owners, although the difficulty of catching someone "in the act" of not removing defecation

What you can't do with a will

While a will is one of the most important estate planning documents you can have, there are things that a will won't cover. A will is just one part of a comprehensive estate plan.

A will is a legallybinding statement

directing who will receive your property at your death. It is also the way you appoint a legal representative to carry out your bequests and that you name a guardian for your children. Without a will, your estate is distributed according to state law, rather than your wishes. Property distributed via a will goes through probate, which is the formal process through which a court determines how to distribute your property.

Although a will is one main way to transfer property on death, it does not cover all property. The following are examples of property you can't distribute through a will:

- Jointly held property. Property that is co-owned with another person is not distributed through your will. Joint tenants each have an equal ownership interest in the property. If one joint tenant dies, his or her interest immediately ceases to exist and the other joint tenant owns the entire property.
- Property in trust. If you place property into a trust, the property passes to the beneficiaries of the trust, not according to
- Pay on death accounts. With a pay on death account, the account owner names a beneficiary (or beneficiaries) to whom the account assets pass to automatically when the owner dies.
- Life insurance. Life insurance passes to the beneficiary you name in the life insurance policy and isn't affected by
- Retirement plan. Similar to life insurance, money in a retirement account (e.g., an IRA or 401(k)) passes to the named beneficiary. Under federal law, a





When the police are on trial

Nine minutes and 29 seconds. That's how long former Minneapolis police officer, Derek Chauvin, pressed his knee into George Floyd's neck on May 25, 2020. We know this because remarkable cell phone video

was shown to the world, and to the nine women and six men who make up the jury in the murder trial of Derek Chauvin.

It's hard to believe that it has only been 10 months since Floyd's death. So much has happened in America since that Memorial Day weekend but it's really a short amount of time for a high profile case like this to come to trial. Chauvin faces three charges: second-degree unintentional murder, third-degree murder and seconddegree manslaughter. If convicted on the highest charge, Chauvin could serve up to 40 years in prison.

We know that historically very few police-related deaths are charged as crimes. And when they are tried, jurors are often hesitant to convict police officers, allowing them wide latitude in using force in the line of duty. In the United States, between 2005 and 2020, of the

42 nonfederal police officers convicted following their arrest for murder due to an on-duty shooting, only five ended up convicted of murder.

The most common offense officers were convicted of was the lesser charge of manslaughter, but even then there were only 11 convictions. (Statista Research Department, June 10, 2020). But the Chauvin trial may be one of the rare instances where an officer is convicted, even of the high crime of murder.

Chauvin's trial has been groundbreaking in many ways. The chief of police testifying against a former officer/ defendant, as was the case in this trial, is almost without precedent. This is significant because even jurors who sympathize with the police will be able to stay loyal to their allegiance to law enforcement and still convict Chauvin, as he will be portrayed as a rogue cop. It is also significant that there were so many bystanders who were able to testify, often with great emotion, about the last moments of George Floyd's life.

When considered along with the video depicting the entire nine-plus minutes, jurors are seeing these events through the eyes of the victim, something that is rarely available in a murder trial. And this may

is very difficult. Judge John requests all citizens' cooperation in asking violators to please comply. Nothing spoils a day at the beach more than a family member stepping in dog-poop left behind.*

The recent Jax Beach law means that the rules regarding when dogs are allowed on the beach are the same between Jax and Neptune Beaches. While always being on a leash, dogs are allowed at any time during the months between October and March inclusive. In all other months, dogs can only be on the beach before 9 a.m. and after 5 p.m. This is both because in our sub-tropical climate the heat can be unhealthy for canines and because our beaches are more and more crowded during those hours raising the opportunity for conflict. Dogs are allowed (again leashed) more hours in both Ponte Vedra and Atlantic Beach.

Leashes are an area where the laws differ. The new Jax Beach law requires a leash of no more than 8 feet — while the 12-foot rule is in effect in Atlantic and Neptune Beaches.

Our understanding is that the 8 feet standard was adopted both for the safety of the dogs themselves and especially for other people enjoying beach activities such as jogging. Judge John can speak from personal experience on the hazards of beach jogging while trying to get around a very long leash, a small dog, and an oblivious owner.

Related to leashes are tethers. In Jacksonville and Jax Beach, it is no longer legal to leave a dog tethered 24/7. In fact, a dog tethered in a yard must be in plain

view of a person at all times. It is our understanding that tethering is unhealthy for a canine and has the tendency to make them vicious. Also, it is required that any dog in the bed of a truck be attached to two tethers. Please report any violations to Animal Control.

Another change in the Jax Beach law is that dog licenses are no longer required.

Both because the rules/laws are different from city to city, and that many beach visitors are not beach residents, Judge John heartily recommends that dog rules be prominently posted at beach accesses, to promote the likelihood of them being followed. We also request that all beach citizens help to gently educate our guests on beaches dog etiquette and laws.

surviving spouse is usually the automatic beneficiary of a 401(k), although there are some exceptions. With an IRA, you can name your preferred beneficiary.

■ Investments in transfer on death accounts. Some stocks and bonds are held in accounts that transfer on death to a named beneficiary. These accounts will bypass probate and go directly to the beneficiary.

In addition to not being able to transfer certain types of property with a will, there are other things that you cannot use a will for. The following are examples of items that should not be included in a will:

- **Funeral instructions.** A will is not the best place to put your funeral instructions. Wills are often not found until days or weeks after death. It is better to leave a separate letter of instruction that is located in an easily accessible location.
- A provision for a child with special needs. If you are leaving money to a child with special needs, a will is

not the best instrument. Receiving an inheritance directly can make the child ineligible for benefits. It is usually better to set up a special needs trust to provide for the child.

- A provision for a pet. You cannot leave money directly to a pet in a will. You can name a caregiver for a pet and provide money to them to care for the pet, but the caregiver is not legally obligated to use the money on the pet. A pet trust is the most secure way to provide for a pet and about 20% of my clients use this method
- **Certain conditions on gifts.** You may be tempted to make gifts conditional on the recipient's behavior or actions. However, there are certain conditions that are not allowed. The condition cannot be illegal, and the gift cannot be contingent on the marriage, divorce, or change of religion of the heir.

A will is not the only component of an estate plan. To make sure your estate plan covers all your needs, talk to your attorney.

be why the verdict will favor the prosecution: the witnesses were distressed because they could not intervene. EMS workers and bystanders all described the guilt they felt watching a man being killed in front of their eyes and not being able to do anything to help. This could

Exhibit features local artists in St. Johns County

Art in Public Spaces program takes artwork to the people

The rotunda of the St. Johns County Administration Building has been transformed into an art gallery for "Outside the Box," an exhibition of works by 20 local artists.

Hosted by the St. Johns Cultural Council and ArtBox, this Art in Public Spaces exhibit features paintings, photography and wood sculpture.

This is not the first Art in Public Spaces exhibit, but previous ones were limited to a single featured artist. This exhibit is the first time an entire gallery has been represented.

"It was quite an undertaking," said Lisa Myers, one of the ArtBox owners. "My business partner, Laura O'Neal, did all the curating. And it's all artists here at ArtBox."

In addition to Myers and O'Neal, artists whose works are represented are: Mel Bashore, Kathryn Carlyle, Charles Edelman, RoAnn Elias, Joyce Hutchinson, Deane Kellogg, Don Kight, Deborah Lightfield, James Macdonald, Patrick Madden, Mare Martelli, Harry McCormick, Anna Miller, Kirsten Miller, Susan Thomas Novy, Michele Renaud, Jim Rivers and Ken Vallario.

In addition, four of the artists have painted large-scale canvases specifically for the exhibit to represent and showcase the beauty of the county. These works, measuring six-by-10 feet, hang around the top tier of the rotunda.

Here's a look at these featured paintings:

- Don Kight's "Early Marley Morning" emphasizes a series of swirls reminiscent of the surf. He calls his style "abstract expressionism mixed with prehistoric pop art." He has decades of freelance experience creating works that include murals, portraits and graphic design.
- Patrick Madden's "Matanzas" depicts the local coastline. The name suggests that it is set on the Intracoastal Waterway. Madden has been an artist, master shaper and surfer for more than 40 years. He has shaped more than 10,000 boards since 1980 and founded Madden Surfboards, where he makes custom-painted and inlaid boards.
- Lisa Myers' "Emergence" is a dynamic swirl of blues highlighted in red that grow from a point of origin to fulfillment across the canvas. Myers studied art history at Old Dominion University, where she learned how abstract impressionists like Willem de Kooning and Mark Rothko approached the canvas.
- Ken Vallario's "Full Moon Marsh" depicts the grasses and waters of the marsh at night. Originally from New England, the landscape painter now lives in St. Augustine. Inspired by American realists Andrew Wyeth and Edward Hopper, he paints coastal scenes with a crisp edge and contemporary sensibility.

"That's the largest thing I've ever painted," said Myers about "Emergence." "It was so much fun."

She said the show has generated interest in the gallery, and vice versa.

"It's been a good fit," she said.

She added that anyone who missed the exhibit at the county administration building can find work by the same artists at ArtBox.

"It's a constant show in here," she said.

The exhibit is supported with funding from the Florida Division of Cultural Affairs and the St. Johns County Cultural Council.

Visitors can see the exhibit between 8 a.m. and 5 p.m. weekdays at the administration building located at 500 San Sebastian View. It is on display through April 29.

ArtBox is a gallery located at 137 King St., St. Augustine. Though it was closed briefly last year for the pandemic, it reopened to the public in May.

Plein Air Paint Out returns to St. Augustine

One of the signature artistic events of the Nation's Oldest City is happening this month: the fifth annual St. Augustine Plein Air Paint Out, hosted by the St. Augustine Art Association.

From April 22 to 25 artists will set up their easels throughout the area, painting pictures of historic locations, like the Lightner Museum, the Castillo de San Marcos, Aviles Street and the Ximenez-Fatio House. Others will go to the beaches or the marshes of Anastasia Island to create their works.

This year, the Paint Out takes on special significance as painters will capture locations found in the Lightner exhibit, "St. Augustine in a New Light: American Impressionism from the Collection of the Lightner Museum." That exhibit opened April 8.

The event celebrates a style of painting known as "en plein air," which translated means "outdoors." It is an approach to painting outside that is fundamental to French Impressionism, beginning around 1860.

It is also a style that Henry Flagler patronized when he brought artists to St. Augustine from around the country to paint the historic town. The Art Association, founded in 1924, marketed this approach, declaring it "like painting in Europe"; the campaign helped the organization survive

the Great Depression.

Plein air artists strive to capture what they see at a particular moment, as lighting, shadows and colors constantly change from sunrise to sunset. Claude Monet is one of the most notable plein air painters and was a forerunner of French Impressionism. Last year, difficulties posed by CO-VID-19 altered the Paint Out event. It was called Plein Air on the Porch. This year, however, the artists will be back in town as they were in 2019, when 70 artists participated.

One focal point of the event is the Quick Draw competition. At 11 a.m. Saturday, April 24, artists will gather in the Lightner Museum courtyard and gardens. They will have two hours to complete a painting. A judge will decide the winners.

The Paint Out is a favorite among passersby, who often stop to watch the artists at work and speak with them about their art.

"There is a sense of comradery and support for the arts during this event that we don't necessarily get to see every day," said Jennifer Flynt, administrator of the Art Association. "I've been a part of the Plein Air Paint Out since its inception in 2017, and it's certainly one of the highlights of the year for our artists."

Artwork completed during the Paint Out will be the subject of a Plein Air Pop Up exhibit during May's First Friday Art Walk.

Rock legends Blue Oyster Cult take stage May 22 at St. Augustine Amphitheatre

On Saturday, May 22, The St. Augustine Amphitheatre will welcome rock legends Blue Oyster Cult with special guests Mark Farner's American Band for a limited-capacity concert with distanced seating. Enhanced safety measures and protocols are in place, including contactless digital ticketing, face covering requirements and mobile ordering for concessions.

For more than four decades, Blue Oyster Cult has been thrilling fans of intelligent hard rock worldwide with powerful albums loaded with classic songs. Indeed, the Long Island, New York-based band is revered within the hard rock and heavy metal scene for its pioneering work. Blue Oyster Cult occupies a unique place in rock history as one of very few hard rock/heavy metal bands to earn both genuine mainstream critical acclaim as well as commercial success.

Farner is also a husband, in his fourth decade of marriage to wife Lesia. He's a family man with five adult sons,



Baseball slowly welcoming fans back to stadiums

Sports fans have been anxiously awaiting a return to normalcy for professional athletics. In 2020, professional sporting events were played in largely empty stadiums and arenas. In instances when fans were allowed in stadiums, capacity was often limited to very small crowds.

As bleak as 2020 might have been for sports fans, good news is on the horizon. Spring heralds the return of many things, including Major League Baseball, which begins its season on April 1. But it may be May before many fans feel comfortable returning to the stands to cheer on their favorite teams.

State and local governments will continue to have major input in regard to determining how many fans will be able to attend live sporting events. In addition, the percentage of fans allowed inside stadiums is likely to change based on fluctuations in COVID-19 cases and regional vaccinations rates.

As of early March 2021, a handful of the 30 MLB teams had yet to release their attendance plans. However, the number of fans who will be allowed to attend games is predicted to range from 10 to 30% capacity in various stadiums. For example, the state of New York is allowing stadiums to open at 10% capacity. That means the Yankees and Mets can seat 5.400 and 4,200 fans, respectively. The Kansas City

Royals will start the season with 30% capacity and Kauffman Stadium has been reconfigured for pod-style seating. The Miami Marlins and Marlins Park are allowing 25% capacity to begin the season, or approximately 9,200 fans.

Baseball fans who find they are unable to get tickets to games or still want to wait a while before attending in person can indulge their love of baseball in other ways.

- Continue to watch games on television and create virtual game watches with fellow fans via Zoom.
- Support local minor league baseball. Check to see what restrictions, if any, local stadiums may have regarding at-
- Plan a road trip to a state that has a large stadium or high capacity volumes for fans.
- Make a pilgrimage to the National Baseball Hall of Fame in Cooperstown, NY. Visits may be governed by certain restrictions, which can be found at www. baseballhall.org.
- Volunteer as a coach for a youth baseball team or attend a high school baseball

Baseball fans have reason to rejoice as the opportunity to enjoy their favorite sport in person is once again possible in many areas.




