# Teen to be tried as adult in girl's slaying

Charge upgraded to first-degree murder in death of 13-year-old Tristyn Bailey

A 14-year-old boy arrested in the slaying of Tristyn Bailey, 13, on May 9 will be tried as an adult, according to court records.

Aiden Sean Fucci of St. Johns was

arrested May 10 and charged with second-degree murder, but the charge was upgraded to first-degree murder after a grand jury hearing.

Friday, May 28, Fucci was transported by the St. Johns County Sheriff's Office

from the Volusia County Juvenile Justice Facility to St. Johns County, where he was booked into the inmate facility and attended first appearance before Judge Howard M. Maltz.

Maltz found probable cause for the first-degree murder charge and remanded Fucci without bond. Fucci was then transported to the Duval County Jail on a courtesy hold.

# Rotary, Recorder recognize residents at annual Local Heroes Awards

The Rotary Club of Ponte Vedra Beach and the Ponte Vedra Recorder recognized seven local residents for their contributions to the community last week at the 29th annual Local Heroes Awards.

Held Thursday, May 27, at Marsh Landing Country Club, this year's event honored residents whose service to the community includes providing fresh produce to families in need, aiding those affected by natural disasters, protecting the environment, providing critical medical care and supporting parents grieving the loss of a child.

Local Heroes Committee Chair Steve Crosby noted that the awards were started in 1993 by former Rotary Club member Vic DiGenti in partnership with the Ponte Vedra Recorder in order to recognize the "unsung heroes" who give back to the community and reflect the spirit of the Rotary Club's motto, "Service Above Self."

The "Local Heroes" Class of 2021 includes:

**JoAnn Wallace:** The president of the board for Dig Local Network – Farmers Markets, Community Gardens and Outreach, Wallace was recognized for her efforts to create and expand programs that provide sustainable food programs to serve the community. In accepting the award, she noted that the COVID-19 pandemic created an even greater need for her organization's food programs. "We were able to sustain people through COVID with dignity," she said.

**Jim Gray and Keith Faver:** Ponte Vedra residents Gray and Faver and their construction company are the longtime sponsor of Wolfson Children's Hospital's Patrons of the Hearts. In addition to bringing more than 50 underprivileged children to Wolfson to have corrective heart surgery, the duo have provided disaster relief in the Bahamas to victims of Hurricane Dorian. Faver recalled the impact meeting the mother of one of the children who received life-saving heart surgery had on him: "I thought, 'Oh my God, this giving thing is pretty cool!'"

**Bill Irwin:** As a disaster action team captain with the American Red Cross, Irwin applies his leadership and asset management skills to coordinate team members for rotation, training and disaster responses. As a DAT captain, he coordinated the initial local response to Hurricane Matthew, the sinking of the El Faro cargo ship and a multifamily fire in Ponte Vedra. "There is nothing more satisfying than walking away from a fire

## Flags adorn Ponte Vedra Boulevard to honor fallen for Memorial Day

Over Memorial Day weekend, American flags adorned Ponte Vedra Boulevard from the Duval County line south on Ponte Vedra Boulevard for four miles.

The project, named Patriotic Ponte Vedra, was initiated to honor the fallen war dead. Two local residents, Belk Ingram, a Ponte Vedra Club Realtor, and John Cellucci, a trustee of the Ponte Vedra Municipal Service District, created the project. The project was presented to the service district trustees, who unanimously voted to support the project and donated \$1,000 to get the project started.

Fundraising was done by word of mouth, including a generous donation by the Ponte Vedra Community Association as well as several dozen Ponte Vedra Beach residents.

Gary Jurenovich, treasurer of the PVMSD was extremely helpful with installation and providing advice. The vendor, Randy Brown of Windy Creations, Jacksonville Beach, was instrumental in obtaining flags and hardware items, which are scarce, from American flag manufacturers that were closed during the COVID-19 pandemic. When the original flags purchased were back-ordered, Brown found a way to meet the project's needs so the project would be successful and on time, and also ensure the flags were made in the United States. The Ponte Vedra Inn & Club also contributed support for the project.

The flags, which were up Friday, May 28, through Memorial Day, Monday, May 31, will also be flown later this year on the Fourth of July and Veterans Day.

## County approves \$16.8M incentive package for new PGA TOUR media center

St. Johns County Commissioners recently approved a \$16.8 million economic incentive package for the PGA TOUR's new broadcast media center to be constructed on Palm Valley Road. The proposed 150,000-square-foot structure would be located next to the TOUR's recently completed Global Home.

The grant will have an estimated annual payout of \$671,150. The grant would cover 25 years of ad valorem and tangible business personal property taxes, including general county tax and the road and fire portion, as well as the impact fee and water and sewer connection fees.

The vote was 4-1, with Commissioner Jeb Smith voting no.

"To me, this is a very far-reaching, extensive increase in regard to the obligation of this contract compared to what we've done in the past," Smith said at the May 18 meeting prior to the vote.

To illustrate his point, he compared the package with that of two large incentives approved previously. He pointed out that the duration of those granted to the Tour's Global Home and a project at Northrop Grumman was four years, whereas the media center contract would be for 25 years.

He also pointed to a lower number of jobs created by the proposed center when compared to the other two projects.

By Sept. 30, 2035, the new media center is expected to create 45 new jobs with an average annual wage of \$79,442 and retain another 135 jobs.

In addition, it would create 724 construction jobs. Construction is expected to begin in March 2022 with completion by March 31, 2024. The cost of the project is estimated at \$100 million, including land, building and equipment.

County staff projected a net benefit for the county of about \$15 million in school taxes over 25 years, \$21 million over 35 years, as well as \$16.2 million in county taxes over 25 years, \$22.7 million over 35 years.

The building would have an estimated annual economic impact on the county of \$304 million.

Commissioner Henry Dean spoke in favor of the agreement, emphasizing the business relationship between the county and the PGA TOUR and the Tour's charitable work locally.

"We are lucky as a county to have the PGA TOUR headquarters here," he said.

The PGA TOUR unveiled its 187,000-square-foot Global Home in January. That building has a capacity of 1,100 employees and replaces 17 smaller buildings at various locations. It is located at 1 PGA Tour Blvd., just off State Road 210.

### **Can you please briefly tell us about your background?**

I have served St. Johns County Emergency Management for 15 years, rising through the ranks of planner, coordinator and to my current position of deputy director.

### **What do you enjoy most about your role?**

My favorite part of my job is public outreach. I get to go into the community and speak to our residents about being prepared and ways they can mitigate their homes and businesses so even when we do have a natural disaster, they will better be able to recover. I have met so many interesting people in our community that I likely would never have had an opportunity to interact with if not for my job.

### **What are some of the challenges that your industry is facing?**

Most people have always considered emergency management the hurricane people, but in the past year, we became the pandemic people. Emergency managers are problem solvers. We have the advantage of working with so many different agencies and groups, that we know who to coordinate with to create solutions.

### **What are your primary roles/responsibilities?**

I spend a great deal of my time coordinating with our partner agencies. We work together to develop plans for all hazards and then coordinate the resources to turn those plans into response actions. I also spend time developing and conducting public outreach programs and activities.

### **What do you enjoy most about living in the North Florida area?**

I enjoy the people and the natural environment. We have some of the most beautiful natural areas anywhere in the state of Florida.

# Ponte Vedra student builds homes for shelter dogs as part of Eagle Scout Project

Becoming an Eagle Scout is no easy feat. It requires time, dedication and a passion for bettering the community. For 15-year-old Gavin Walker, this was an ideal task.

The Ponte Vedra High School student gained recognition in his community last fall for his business, Flocking Flamingo PVB, where customers could contact Walker to place dozens of pink, plastic flamingos in friend's/family's yards for their birthday or other celebration surprises.

It was in this same time frame that Walker was working on becoming an Eagle Scout, which required completing his Eagle Scout Project. According to The National Eagle Scout Association website, Requirement No. 5 (which is the project) is the toughest requirement in the bunch, which is why they encourage young Scouts to pick a project they are passionate about.

Walker chose to hand-build six dog houses for animals in need at the Animal

Care & Protective Services of Jacksonville. After adopting a family dog just two years ago, Walker knew that he wanted his Eagle Scout Project to revolve around helping less-fortunate animals.

"[This project] will raise awareness of how much they are in need, and how much of a problem it can be — dogs not having homes," said Walker.

ACPS provided the blueprints and Walker, along with 20 of his fellow Scouts, got to work constructing the doghouses. Once they were finished, they gave the houses to ACPS, who then distributed them to dogs in need.

The process of completing the Eagle Scout Project is a lot of paperwork, according to Walker. It involves writing a proposal for a project, getting approval, writing a project plan and carrying it out, then writing a follow-up report on the project. After the follow-up, the Scout must take the report in front of a chairman of the troop, and eventually submit it for review

“This is going to be a long road for the Bailey family and our community,” Hardwick added and asked that the public continue to respect the Bailey family’s privacy and keep them in their thoughts and prayers.

A felony arraignment has been scheduled for 9 a.m. June 10.

Bailey, who lived in the area of Durbin Crossing, was reported missing by her family at about 10 p.m. May 9. The Sheriff’s Office sent out a mass notification to the public, the media, the school district and community partners.

A resident of the community, hearing

the report, began to search a wooded area near his home and, at about 6 p.m. May 10, discovered a body later confirmed to be that of Tristyn Bailey. The body was found at the south end of a retention pond just to the east of the Saddlestone Drive cul-de-sac.

Chief Medical Examiner Dr. Predrag Bulic determined that the cause of death was sharp force trauma by stabbing.

“To say that it was horrific could arguably be made as an understatement,” said 7th Circuit State Attorney R.J. Larizza in a press conference announcing the upgrade in charges on Thursday, May 27. “The medical examiner completed an autopsy on our victim and identified, confidently, that there were 114 stab wounds.”

He added that “teenagers are capable of

things we never imagined they could be, and this case is an example of that.”

Fucci was initially held by the Department of Juvenile Justice because he was a minor. He was first represented by attorney Anwar O. Snober, who filed a motion to withdraw from the case May 17. The withdrawal was approved three days later.

Fucci was granted indigent status on May 20 and assigned a public defender on Thursday, May 27.

The grand jury was convened the same day and unanimously indicted Fucci, upgrading the charge to first-degree murder.

Following the indictment, the St. Johns County Sheriff’s Office issued a statement fully supporting the decision.

process,” the statement read. “We remain confident in the strength and thoroughness of the investigation and will be fully prepared to present all of the facts and evidence to a jury at the appropriate time.”

The Sheriff’s Office went on to thank the State Attorney’s Office, the Florida Department of Law Enforcement and the Medical Examiner’s Office.

“From day one, our teams have worked side-by-side, furthering the investigation and preparing this case for a grand jury,” the statement continued.

The Sheriff’s Office stated that detectives would continue to investigate all leads and evidence.

“We remain steadfast in our commitment to ensure justice and accountability is served,” the statement read.

at 4 in the morning knowing you were able to help people when they needed it most," he said.

**Debbie Shearer:** After tragically losing her son to hospital-acquired sepsis 14 years ago, Shearer dedicated herself to helping others. In addition to donating a kidney to a stranger, she founded Parents with Hope, a local support group for parents who have lost a child. "This is a

group no one wants to join," Shearer said. "We have all struggled with finding community and being able to relate to people. But when you find others (to support you), the healing can begin."

**Kevin Brown:** A marine science teacher and community volunteer leader, Brown organized students to plant sea oats in the dunes, educating them about the environment in the process. "People used to laugh at us," Brown recalled, "until Hurricane Matthew and Irma happened, and those sea oats held the water back. Those kids thought they saved the beaches!

"We have a fabulous place where we live," Brown continued, "and I just want to keep it that way."

**Janie Kratzert:** The president of the Heartstrings Foundation, Kratzert recalled how the organization began when a group of local Ponte Vedra parents began hearing through the grapevine about local students or families in need. "We didn't all have big pocketbooks, but we had big hearts," she said. That heart for giving has led the organization to anonymously help local residents in need. "Whether it's buying textbooks for a homeless student or providing groceries or gas cards to families, it may not seem like much, but it can make such a difference to them when they need it most."

## ST. JOHNS COUNTY EVACUATION ROUTES

Below is guidance on where St. Johns County residents should evacuate during an emergency situation.

**Ponte Vedra Beach/Sawgrass:** North on SR-A1A, turn west onto Butler Boulevard and proceed to I-95 or points west.

**Palm Valley/Nocatee area:** Proceed southwest to CR-210 and proceed to I-95 or points west.

**On coast halfway between Mickler's Landing and South Ponte Vedra Beach:** North of Guana Dam, go north to SR-A1A and proceed west across Palm Valley Bridge on CR-210. South of Guana Dam, go south on SR-A1A and proceed west across Vilano Bridge. Continue west on SR-16 to I-95 or points west.

**City of St. Augustine (mainland):** North on US-1, turn west onto SR-16 or proceed southwest on SR-207 or south on US-1. Proceed to I-95 or points west.

**City of St. Augustine (Davis Shores, Anastasia Island South to St. Augustine Alligator Farm):** SR-A1A, proceed west across Bridge of Lions to US-1 North or US-1 South and/or to SR-16 or SR-207 to I-95 or points west.

**City of St. Augustine and Anastasia Island north of the St. Augustine Amphitheater:** Proceed north on SR-A1A across the Bridge of Lions and then go west.

**City of St. Augustine and Anastasia Island south of the St. Augustine Amphitheater:** Proceed south on SR-A1A, turn west on SR-312, proceed across 312 Bridge to SR-207 and proceed to I-95 or points west.

**City of St. Augustine Beach:** North to SR-312, proceed across 312 Bridge to SR-207 and proceed to I-95 or points west.

**From the intersection of Ocean Trace Road and A1A to Crescent Beach:** South on SR-A1A to Crescent Beach, turn west on SR-206, proceed across Crescent Beach Bridge to US-1 and proceed to I-95 or points west.

**Crescent Beach to Flagler County Line:** North on SR-A1A to Crescent Beach, turn west on SR-206, proceed across Crescent Beach Bridge to US-1 and proceed to I-95 or points west.

### ST. JOHNS RIVER

**SR-13 north of CR-210:** Proceed east along CR-210 or Greenbriar Road to I-95; or north along SR-13 into Duval County; or east on Racetrack Road to areas outside the evacuation zone.

**SR-13 north of CR-214:** Proceed east along CR-208 or SR-16 to I-95; or west along SR-16 across the Shands Bridge; or east on CR-214 to areas outside the evacuation zone.

**CR-13 South of CR-214:** Proceed east along SR-207 or SR-206 to I-95; or west along SR-207 into Putnam County; or east on CR-214 to areas outside the evacuation zone.

- **Take Inventory** – Update your home inventory by walking through your home with a video camera or smart phone. Keep

a record of large purchases including the cost of the item, when purchased and model and serial numbers as available. Store important documents in a portable waterproof container.

■ **Stock Emergency Supplies** – Plan for a week's worth of non-perishable food and water. Be sure to have flashlights, extra batteries, battery-powered radio, medications, first aid kit, blankets, toiletries, diapers, cleaning supplies, etc. Prepare a portable kit to keep in your car should you need to evacuate.

■ **Identify a Safe Room** – Identify a room where family members should gather, in case of emergency. This is typi-

cally an interior room with no windows.

■ **Protect your Property** – Review your homeowners insurance with your licensed insurance agent to determine if you have adequate protection. Discuss your deductibles. Be aware that flood insurance is not typically covered under your homeowner's policy. Flooding coverage for your automobile is available via an optional "comprehensive" inclusion to your auto insurance policy.

# Important things for any homeowner to know concerning hurricanes

Hurricane season began Tuesday, June 1, and will end Nov. 30. The NOAA outlook predicts a likelihood of 13-19 named storms, 10 of which are likely to become hurricanes, and three to five of those expected to be major hurricanes.

Local residents are used to preparing by getting plenty of water, food, gas, etc. However, what if your home or business is damaged?

If you own a home you most likely have a regular homeowner's insurance policy. If a pipe breaks in your home you are most likely covered for all but your deductible. However, if you have rising water due to a storm, your insurance policy, most likely, will not cover this.

When I think of Jacksonville, I don't think "If" it's going to happen, I think "when" is it going to happen. I highly recommend purchasing a flood policy for your home whether or not the city says you are in a "flood zone."

As the owner of PuroClean Emergency Services, most of the storm floods I come across, the building owner says, "This has never happened to me before." Or, "This has never happened in this neighborhood before."

It is important to know that if you have a flood policy, it still might not cover all the costs associated with a flood. However, it will cover a good portion. This is something you should talk to your insurance agent about. Flood insurance is very inexpensive, and I would call this a great

safety measure.

If your home or business is flooded from a storm, I would not recommend trying to take care of the damage yourself. Call a professional restoration company, such as PuroClean Emergency Services. Restoration companies deal with insurance companies all the time and know the proper ways to make sure your insurance company is taking good care of you. Do not take a fast payout offer, as they are usually lower than what it would cost to restore a property properly.

Although water losses are assigned a category of 1, 2, 3 and sometimes 4 (not to be mixed up with the category of a hurricane), water coming in from the outside is always at least a 3 if not 4. This is because the water coming in from outside could have pesticides, animal urine, automobile oils and gases and other unknown ingredients. Anything this water touches should be discarded with the exception of structural items, which should be disinfected and dried out as soon as possible.

The last thing to know is that if FEMA is involved and your flood has been sitting there long enough to cause mold, FEMA will not cover mold-related activities. It is important to discuss this with your restoration company at the time of inspection so if there are any additional charges you know what they are.

to contact your family members, alternate meeting locations, and an out-of-town contact person. Anticipate limited cell phone service.

■ **Know Your Evacuation Route** – Go to FloridaDisaster.org to track the recommended evacuation route for your region.

■ **Choose Multiple Destinations** – Identify several places you will go in an emergency, such as a friend's home, in another town, a hotel or shelter. Choose destinations in different directions so you have options during an emergency.

■ **Research Shelter Availability** – Check with local officials about the availability of evacuation shelters. Your regular shelter may not open this year due to COVID-19. If you evacuate to a community shelter, follow the latest guidelines from the CDC.

■ **Prepare your Pets** – Identify a place to stay that will accept pets. Most public shelters allow only service animals.

■ **Prepare your Vehicle for Evacuation** – Have your vehicle professionally inspected so it's ready for evacuation. Plan to take one car per family to reduce congestion and delay.

■ **Gas Up** – If an evacuation seems likely, ensure you have a full tank of gas. Fuel responsibly. Do not hoard gasoline. The pre-storm surge in gasoline demand often leads to temporary fuel outages before the storm. After the storm, be aware that gas stations may be closed or unable to pump gas due to structural damage or power outages. As a result, AAA suggests you begin looking for a refueling option after your tank drops below half full.

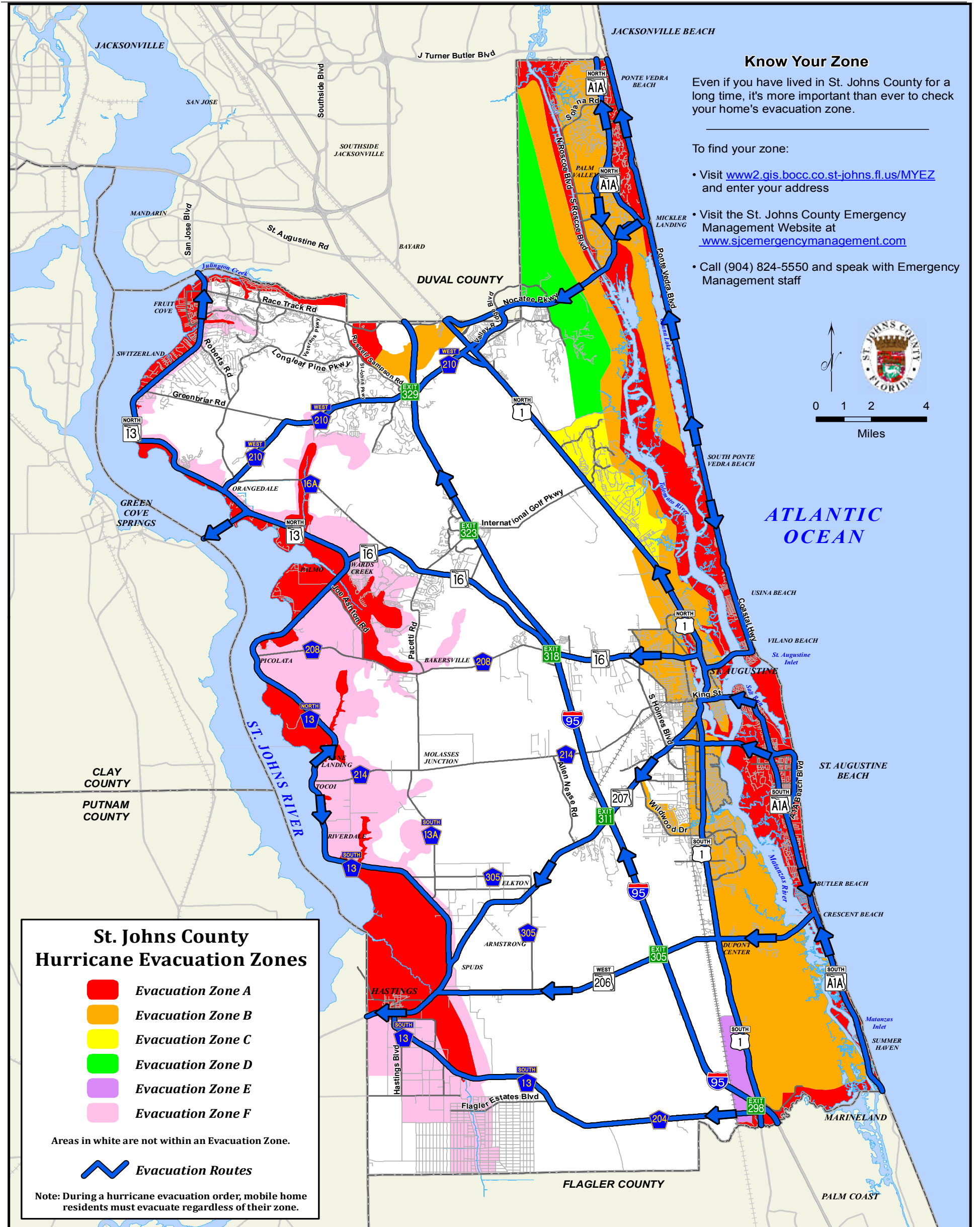

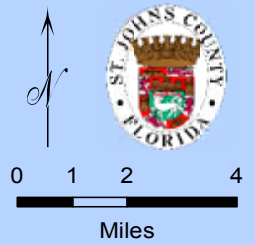

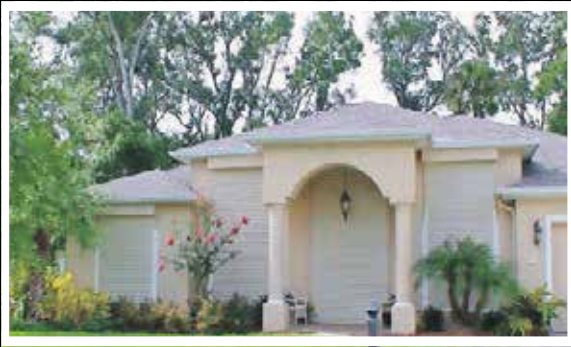

It's only a matter of time before a large hurricane makes landfall in North Florida. It doesn't take a Category 5 storm to damage a home or property. During its life-cycle, a hurricane can expend as much energy as 10,000 nuclear bombs, according to NASA. Forty percent of all hurricanes that occur in the United States hit the State of Florida. Storm shutters come in a variety of styles that can provide peace of mind during the Florida hurricane season, as well as improve the exterior appearance of your home and even increase the value of your home.

## WHY INVEST IN STORM SHUTTERS?

Significant storm damage, torn-apart buildings, blown-off roofs and much more often start with just a broken window and internal pressurization.

Rapid intensification, also known as RI, is defined by the National Hurricane Center as an "increase in the maximum sustained winds of a tropical cyclone of at least 34.5 mph in a 24-hour period." Rapid Intensification can occur regardless of the storm strength or size and is becoming increasingly more common. Rapid intensification is a serious challenge for the prediction of hurricane intensity. An example is Hurricane Laura that went from a tropical storm with sustained winds of 65 mph early Aug. 25, 2020, to a Category 3 with 115-mph winds the next morning, Aug. 26, 2020. Laura increased into a major Category 4 hurricane before landfall early Thursday, Aug. 27, 2020.

Hurricane shutters can deliver "full envelope" protection of your home or commercial property against

hurricane-force winds, preventing internal pressurization of the building. Internal pressurization happens when strong gusts of wind push into the building, and force upward, creating pressure while wind from the exterior of the building compromises the truss system. The resulting set of forces lifts the roof off because of this massive buildup in pressure. This internal pressurization is what causes the often-seen roof lift-off and associated catastrophic damage.

## WHY SHOULD I PROTECT ALL OF THE OPENINGS OF MY PROPERTY?

Unfortunately, wind and debris can come from any direction depending on your property's relationship to the storm eyewall and the direction of the hurricane's travel. If one opening is compromised, the property can be vulnerable to rapid internal pressurization.

## DOES INSTALLING HURRICANE SHUTTERS LOWER MY HOMEOWNER'S INSURANCE?

Florida law requires insurance companies to offer homeowner's insurance discounts or credits for existing building features or home improvements that reduce damage and loss from hurricanes. Most insurance companies offer a discount when you have protected all of the glazed openings on your house. Contact your insurance company for their requirements.

Many insurance companies are requiring homeowners to install approved hurricane protection. This reduces claims to the insurance carrier and protects homeowners from storm damage.

Florida law requires insurance companies to offer

homeowner's insurance discounts or credits for existing building features or home improvements that reduce damage and loss from hurricanes.
